A motion by Leonard and seconded by Drey to approve the Clerk of Court report. Motion carried, all voting Aye.

A motion by Schubert and seconded by Drey to amend the agenda to include a closed session pursuant to Iowa Code 21.5 (1)(i) to discuss the custodial position. Motion carried, all voting Aye.
