County Attorney Meghann Whitmer and Glen Winekauf, CEO-Horn Memorial Hospital were present to discuss the Medical Examiner/Death Investigator training contract with Horn Memorial Hospital. Since not all death investigators are employees of the hospital, Mr. Winekauf requested that these individuals have separate contracts with the county for these services. Mr. Winekauf also informed the Board that Dr. Hesse, Medical Examiner will be receiving training in St. Louis and requested the training expenses be reimbursed. He also informed the Board that Dr. Hesse would like another Medical Examiner Associate. There is also some Horn Memorial staff that is interested in becoming a Death Investigator. The County Attorney will prepare contracts for these individuals. Leonard moved and Drey seconded the motion to reimburse training expenses for the Medical Examiner and Death Investigators. Motion carried, all voting Aye.

County Engineer Jeff Williams requested that the Board amend the agenda to include action with regards to a contract with Asphalt Surface Technologies Corporation and a utility construction permit for MidAmerican Energy. Drey moved to amend the agenda to include the said items. Leonard seconded the motion and it carried, all voting Aye.

Leonard moved to approve and authorize the Chair to sign a contract with Asphalt Surface Technologies in the amount of \$543,563.39 for L51 and D22 Microsurfacing. Drey seconded the motion and it carried, all voting Aye.

A motion by Leonard and seconded by Schubert to approve and authorize the Chair to sign an application for approval of under-ground construction for MidAmerican Energy for fiber cable located along $230^{\rm th}$ and $240^{\rm th}$ St. in Blaine Township. Motion carried, all voting Aye.

Drey moved to approve and authorize the Chair to sign Resolution 19-31 Ida County Secondary Roads Policy on Purchase of Right-of-Way. Leonard seconded the motion and it carried, all voting Aye. Resolution 19-31 is on file and maybe reviewed in the Auditor's Office or on the Ida County.org website.

Leonard moved and Drey seconded a motion to approve and authorize a change order from Cedar Valley Corp in the amount of \$340 for subgrade stabilization, cement powder and also approve a pay estimate in the amount of \$277,269.41 Motion carried, all voting Aye.

Engineer Williams discussed options to increase weight capacity on various bridges. He also updated the Board on availability of bonding funds with regards to proposed projects.

Nikki Goodchild, Cottingham/Butler Group Benefits was present to discuss and review their employee benefits consulting and services.

Ed Sohm was present to recommend approval of a proposed construction permit application for Mason Goodenow in Section 12 of Garfield Township. The proposed structure will be converted from swine sows to swine finishers and increase animal numbers to 3000 head of swine finishers with no new construction. Schubert moved and Drey seconded a motion to approve and authorize the Chair to sign said recommendation. Motion carried, all voting Aye.

Drey moved to approve the draft Citizen Convenience Center Permit Renewal. Leonard seconded the motion and it carried, all voting Aye.

A motion by Drey and seconded by Leonard to approve and authorize the Chair to sign a bid from A-1 Preferred for ductwork cleaning in the amount of \$34,950. Motion carried, all voting Aye.

Leonard moved to approve the Clerk of Court report. Drey seconded the motion and it carried, all voting Aye.

A motion by Leonard and seconded by Drey to approve Zach Hall as the Conservation Director for a salary of \$43,000, effective August $19^{\rm th}$, 2019. Motion carried, all voting Aye.

The Board acknowledged receipt of manure management plans from Alesha Finisher Farm/H & R Partnership; Battle 14 Farms/Robert Butcher.
