RESOLUTION MAKING AWARD OF CONSTRUCTION CONTRACT AND APPROVING  
CONSTRUCTION CONTRACT AND BOND FOR THE D15: FROM IA 31 TO L51  
RESURFACING WITH WIDENING PROJECT

**WHEREAS**, at the June 12<sup>th</sup>, 2018 Ida County Board of Supervisors Meeting, staff was authorized to publish notices for an July 9<sup>th</sup>, 2018 bid letting at 10:00 A.M. and to advertise and publish notices to conduct a public hearing on July 9<sup>th</sup>, 2018, at 10:00 A.M. to approve the plans, specifications, form of contract, and estimate of costs for the D15: From IA 31 To L51 Resurfacing with Widening Project; and

**WHEREAS**, notice of Public Hearing and Letting was published in the Ida County Courier newspaper on June 27<sup>th</sup>, 2018, in accordance with the public bid letting and public hearing notification requirements of the Code of Iowa; and

**WHEREAS**, a bid letting was held on July 9<sup>th</sup>, 2018, at 10:00 A.M. at 401 Moorehead Street, Ida Grove, Iowa; and

**WHEREAS**, the Consultant recommended the award of contract to the lowest responsive, responsible bidder, being Croell, Inc. of New Hampton, Iowa, in an amount of \$2,509,158.63.

**NOW, THEREFORE, BE IT RESOLVED** that the base bid of Croell, Inc. of New Hampton, Iowa, in the amount of \$2,509,158.63, for the construction of the D15: From IA 31 To L51 Resurfacing with Widening Project, described in the plans and specifications heretofore adopted by this Board for said projects, after notice of public hearing being published as required by law, be hereby accepted, the same being the lowest responsive, responsible bid received for said work; and

**BE IT FURTHER RESOLVED** that the Chair of the Ida County is hereby directed to execute the contract with the contractor for the construction of the public improvements, such contract not to be binding on the County until approved by the Board.

**RESOLUTION ORDERING CONSTRUCTION OF THE D15: FROM US 59 TO GALVA  
RESURFACING WITH WIDENING PROJECT, AND FIXING A DATE OF HEARING  
THEREON AND TAKING OF BIDS**

WHEREAS, it is deemed advisable and necessary to construct certain public improvements described in general as the D15: From US 59 To Galva Resurfacing with Widening Project; and

WHEREAS, JEO Consulting Group, Inc. has been selected to complete construction plans, specifications and form of contract, together with estimate of cost, which are now on file in the office of the County Clerk for public inspection, for the construction of the public improvements; and
