It was also noted that the Board had contacted several companies which were not interested or able to do a such a large project.

Supervisor Leonard also reported that Conservation Director Zach Hall was in favor of utilizing the Conservation Center as a Courtroom if needed, depending upon the results of the air quality report. The Board acknowledged receipt of manure management plans from Alesha Finisher
