Leonard moved to approve and authorize the Vice-Chair to sign an Iowa DOT permit application with regards to Frontier Communications crossing Hwy 59. Drey seconded the

motion and it carried, all voting Aye. A motion by Leonard and seconded by Drey to approve and authorize the Vice-Chair to sign an application for underground construction for North West REC to upgrade and build a new line on the opposite side of the road, located along Landmark Ave in Logan, Silver Creek and Corwin Townships.
