

The Board of Supervisors convened in adjourned session, members present Vice-Chair Raymond Drey, and Rhett Leonard. Creston Schubert was absent.

Minutes of the meeting held May 26, 2020 were read and approved. It was noted that the Board of Supervisors met at 1:00 p.m. instead of 9:00 a.m. on June 9, 2020.

Dan Conover, Custodian was present for his annual review. He declined a closed session.

County Engineer, Jeff Williams presented a County Right of Way Agreement for Randy Todd/Joy Dirt Construction located between 100th and 110th St by half mile line on Brady Ave. Leonard moved and Drey seconded a motion to approve and authorize the Chair to sign said agreement. Motion carried, all voting Aye.

Leonard moved and Drey seconded a motion to approve and authorize the Chair to sign Gus Construction Claims #2 \$171,032.11 and #3 \$72,512.52. Motion carried, all voting Aye.

A motion by Drey to approve and authorize the Chair to sign a claim in the amount of \$580,782.69 for Cedar Valley on the M31 project. Leonard seconded the motion and it carried, all voting Aye.

Leonard moved and Drey seconded a motion to approve and authorize the Chair to sign a temporary construction easement in the amount of \$787.09 for Steve Graham located in Section 18/89/41 on the D-15 Bridge by Hwy 31. Motion carried, all voting Aye.

A motion by Drey and seconded by Leonard to approve and authorize the Chair to sign an application for underground construction for West Central Iowa Rural Water located at Noble Ave from Blaine Section 29 into Blaine Section 28. Motion carried, all voting Aye.

Various Secondary Road staffing issues were discussed.

After declining a closed session, an annual review was held with Engineer Jeff Williams.

Leonard moved to approve and authorize the Chair to sign a 3 year renewal contract for fiscal years 2020-2022 in the amount of \$4,125 for Cost Advisory Services, Inc. Drey seconded the motion and it carried, all voting Aye.

A motion by Leonard and seconded by Drey to approve and authorize the Chair to sign a donation letter for the Ida County Fair Board from the 2020 America's Farmers Grow Community Donation to be deposited into the Ida County Foundation Trust Fund. Motion carried all voting Aye.

Resolution 20-25, 28E Rolling Hills Community Services was tabled for the next meeting.

A motion by Leonard and seconded by Drey to approve and authorize the Chair to sign a contract for Nyhart for FY 2020 in the amount of \$3,750. Motion carried, all voting Aye.

Drey moved and Leonard seconded a motion to approve a contract with Gaylen Wunschel for landfill mowing in the amount of \$1,000-\$500 due July 10, 2020 and \$500 due Sept 1, 2020. Motion carried, all voting Aye.

Due to Covid-19 situation, Leonard moved to approve \$12 per hour for 2020 Primary Election Poll Workers. Drey seconded the motion and it carried, all voting Aye.

The Board then proceeded to canvass the returns of the Primary Election held, Tuesday, June 2, 2020.
