

## IDA COUNTY ORDINANCE NO. 15

Title: An ordinance re-adopting the existing county code and amending and/or repealing certain portions therein, Ida County, Iowa.

Be It Enacted by the Board of Supervisors of Ida County, Iowa:

**SECTION 1. Purpose.** Code of Iowa Section 331.302, subsection nine, requires that once every five years a County shall compile its code of Ordinances. This ordinance readopts ordinances already in effect and amends certain ordinances and repeals any ordinance deemed no longer necessary to the operation of Ida County, Iowa or to the health, safety, and welfare of its citizens.

**SECTION 2. Readoption and Amendment of Current Code.** The following ordinances, have been previously adopted and enacted into law and were duly published as the law provides. They are stated herein by number and subject matter and by the authority of the Ida County Board of Supervisors comprise Ida County Code of Ordinances:

1. No. 2 Zoning Ordinance, in its entirety.
2. Amendment to the Zoning Ordinance, in its entirety.
3. No. 4 Industrial Property Tax Credit Authorization, in its entirety.
4. No. 5 Readoption of Existing Ordinances
5. No. 6 An Ordinance requiring the Sanitary Storage, Collection and Disposal of Solid Wastes and Yard Wastes and Providing for Violations, in its entirety.
6. No. 7 Readoption of Existing Ordinances
7. No. 8 An Ordinance Adopting rules for the Construction and abandonment of Private water wells in Ida County, in its entirety.
8. No. 9 An Ordinance Adopting Rules for the Installation of ON-SITE Wastewater Treatment and Disposal Systems in Ida County, in its entirety.
9. No. 10. An Ordinance Establishing a Local Option Sales and Services tax Applicable to Transactions Within The Incorporated Area, City of Galva, of Ida County, in its entirety.

An Ordinance requiring that persons responsible for the storing, handling and transportation of Hazardous Materials shall at their own cost clean up any spills of those materials and providing remedies for the County to clean up spills if the responsible party fails to do so, and to recover the costs for the county, in its entirety.

14. Amendments to Ordinance No. 6

Summary of Amendments

Various definitions contained in the Ordinance terms have been updated to comply with the current Iowa Code.

Section 7-(Addition) Separation of Yard Waste Required

Brush and tree limbs are not accepted at the landfill, they may be taken to the location designated by the resident's respective City Council.

Section 8-(Amended) Yard Waste Containers

All yard waste to be collected shall be placed and maintained in containers or packages authorized by the resident's respective City Council or as accepted by the resident's collector. Brush and tree limbs shall be sized to accommodate the requirements of the collector and any pertinent City Council ordinances.

Section 13 A-(Addition) Prohibited Wastes

3. Waste oil and undrained oil filters. 5. Unseparated yard waste. Separated grass, leaves and other non-woody waste will be accepted for composting. 6. Brush and trees. 7. Recyclable as defined by County Ordinance 16. 8. Appliances (also known as white goods). 9. Tires. 10. Mercuric-oxide and nickel-cadmium batteries. 11. Infectious and biomedical waste as defined by the Iowa Department of Natural Resources. 12. Other wastes that may be prohibited by state and federal regulations.

Section 13 B-(Amended), Special waste may be accepted provided a special waste authorization has been issued by the Iowa Department of Natural Resources. The Board of Supervisors or the Manager shall establish appropriate charges for special wastes as appropriate for the type of waste and all costs relative to disposal of the special wastes. All assessed costs will be borne by the hauler and/or generator of the special waste.

15. Amendments to Ordinance No. 13

Summary of Amendments

Various definitions contained in the Ordinance terms have been updated to comply with the current Iowa Code.

C. Containers for Collection (Amended)

1. Solid Waste-Solid waste, not including recyclable materials, shall be placed in plastic bags and/or in a waste storage container as defined in Ordinance No. 15, Section 8, and as authorized by the city/county. When filled, bags/containers shall weight no more than 50 pounds per bag/container unless it is an approved container designed to be mechanically emptied.

2. Recyclable-Recyclable materials shall be placed in a separate container for recyclables only. Jars, bottles, aluminum products, tin cans and plastic containers (co-mingled items) shall be placed in the bottom of the recycling bin. Corrugated cardboard bundles should be placed on top and weighed down by bagged or bundled paper products to prevent blowing. Paper products should not be mixed with co-mingled items.

D. Preparation & Placement of Recyclable Materials for


Collection (Addition)-5. HDPE(#1) and PET (#2) plastic containers shall be rinsed, metal and plastic rings removed and placed in the recyclable container(s), either curbside or at the recycling center.

IV. Collection by Unauthorized Person (Addition)-All collected recyclables are required to go to the Ida County Recycling Transfer Station for processing. This shall not prevent a business for arranging for independent collection and processing of its own recyclables generated on its own property, provided that the recycled tonnages are periodically reported to the landfill manager.


**SECTION 3. Code of Ordinances.** Copies of the code as adopted herein shall be on file and available for public inspection in the office of the County Auditor in the Ida County Courthouse, Ida Grove, Iowa.

**SECTION 4. When Effective.** This ordinance shall be effective after is final passage, approval and publication as provided by law.
