

Ordinance 25

AN ORDINANCE ESTABLISHING THE COUNTY SUPERVISOR DISTRICTS AND ELECTION PRECINCTS

BE IT ENACTED by the Board of Supervisors of Ida County:

Section 1. Purpose: The purpose of this ordinance is to establish election precincts and County Supervisor districts as the result of the population changes reflected by the 2010 federal decennial census, in accordance with Iowa Code Sections 331.210A and 49.7.

Section 2. Supervisor Districts: WHEREAS, the Code of Iowa stipulates that County Boards of Supervisors shall be organized and operate under one of three enumerated Supervisor plans; and

WHEREAS, Supervisor Plan "Three" was selected pursuant to Section 331.210 at an election held February 24, 1976; and

WHEREAS, the Code provides that following each federal decennial census, the Board shall divide the county into supervisor districts of equal population.

NOW, THEREFORE, BE IT ORDAINED by the Board of Supervisors of Ida County, Iowa, that Ida County, Iowa be and is hereby divided into three supervisor districts as follows:

District #1 – District #1 shall consist of Galva, Griggs, and Douglas Townships. Population – 2369
and City of Holstein and Galva City

District #2 – District #2 shall consist of Battle, Logan, Maple, Garfield, Grant, Hayes, Blaine and Silver Creek Townships. Population – 2331 and City of Arthur and Battle Creek City

District #3 – District #3 shall consist of Corwin Township. Population – 2389
and City of Ida Grove


Section 3. Legal Description of Precincts:

NOW, THEREFORE BE IT ORDAINED by the Board of Supervisors, Ida County, Iowa, that changes in the new precincts shall be established as follows:



1	Ward I, City of Ida Grove & part of Census Block 2049 (NW1/4 of SE1/4 & Pt. of SW1/4 of SE1/4 lying east of Badger Creek Sect 23 Corwin Township	735
2	Ward II, City of Ida Grove	717
3	Ward III, City of Ida Grove and Corwin Township, less Census Block 2049 (see Ward 1)	937
4	Blaine, Hayes & Silver Creek Townships (including the City of Arthur)	736
5	Galva Township (including the City of Galva	588
6	Griggs and Douglas Townships (including the City of Holstein)	1781
7	Battle, Logan, Maple, Garfield & Grant Townships (including the City of Battle Creek)	1595
